Effective interest rate duration is a measure of the sensitivity of a bond's price with respect to a shift in U.S. interest rates. It approximately measures the percentage change in a bond's price if U.S. interest rates change by 100 bps.

Option-adjusted spread (OAS) is a measure of the spread of a fixed income investment's yield relative to a benchmark, adjusted to take into account an embedded option.

Credit quality ratings are assigned to underlying securities in accordance with the methodology applied by the Fund's benchmark. The Fund itself has not been rated. Credit ratings are subject to change.

Current Yield: Current yield is the income generated by a security over the course of one year, divided by the current market price of the security. A fund's current yield is calculated by averaging the current yield of each security held within the portfolio on a market weighted basis.
